FORMOSA PLASTICS causes fish mortality in Vietnam

In 2009 the owners family Wang, the chairman of FORMOSA PLASTICS GROUP (FPG), Lee Chih-tsuen, as well as the executive management of the enterprise from Taiwan were denounced internationally with the International ethecon Black Planet Award by ethecon – Foundation Ethics & Economy due to their responsibility for crime against man and environment. Today, seven years later, FPG again hit the headlines worldwide. Because of an ecological disaster in Vietnam with a devastating dimension. FORMOSA PLASTICS GROUP must be stopped.

FORMOSA PLASTICS GROUP (FPG) has its roots in the anti-communist separation of Taiwan from China after World War II, which was illegal to international law, and in the times of Cold War (find more on Wikipedia and other internet encyclopaedias). Wang Yung-ching founded FPG in 1954 with American money. As a consequence he became one of the world's most wealthy men until his death in 2008, with assets of 6,8 billion US dollars.

Anti-communism and Cold War

FORMOSA PLASTICS GROUP (FPG) is one of the world's biggest chemicals group. It has a sales volume of 78 bn US dollars, numerous subsidiaries in China, Vietnam and other countries, among also in the USA, as well as 106 thousand employees. Production focuses are on chemistry, biotechnology, electronics, cosmetic, household chemicals, automotive parts and pharmaceuticals.

The group's history goes along with a permanent line of social and ecological crimes all over the world.

In 1998, for example, FGP was caught, while 3.000 tons of toxic waste should be simply sunk in the sea at the Cambodian seaport Sihanoukville.

The soils, the air and the water around the factories in the world are poisoned, destroy environment and represent hazard for the people's life.

Time and again there are casualties and severely injured due to accidents, explosions and near disasters. In

Internationaler ethecon Black Planet Award

ethecon - Foundation Ethics & Economy shamed the owners and responsible managers of the chemicals group FORMOSA PLASTICS GROUP (FPG) from Taiwan with the International ethecon Black Planet Award 2009. Just because of greed of gain they spurn essential principles of human ethics and ruin our Blue Planet.

ethecon demands, that the managers and owners of FPG will be liable for all environmental and other damages, caused by the group, and if applicable also will be punished.



Illinois the surrounding townships even had to be evacuated.

In Taiwan the company is on the list of the 10 biggest polluter. 25% of all greenhouse gases emitted in Taiwan fall upon FPG.

Currently: fish mortality in Vietnam

Beginning of 2016 the steel mill FORMOSA HATINH STEEL was launched in Vietnam. One pipeline goes from the mill to the ocean.

It is officially prohibited for the group, to dump used and polluted water into sea, but it has not been checked so far. FPG does not explain in any way, which substances they dispose to the sea through the mentioned pipeline.

Thus it resulted in a huge fish mortality of 200 km along the coast of four Vietnamese provinces. Besides the vast consequences for the ecological balance in that region, people are also endangered. When consuming polluted fish, health damages are the consequence. Local media already report on a casualty in conjunction with the huge water pollution.
