
DONATION REPORT FROM MY 2 ANTI-ATOM-LECTURE-TOUR (03 Nov. 2017 in Hamburg/Germany and 07.Nov. 2018 in Hamburg, 20 Nov. Fulda, 21 Nov. Lindau, 22 Nov. Mannheim/Deutschland, 24.Nov. Keswick/England)

Dear friends:

Also in the summer of 2018 and 2019, I was able to invite children and their parents from Fukushima to take a cure in the Peninsula Izu in Japan with your donations from 2017 and 2018. I thank you very much for your support.

Fukushima Prefecture and its surrounding areas are still in constant health danger from radioactive radiation.

1. General situation of the children in / from Fukushima:

The government, the relevant ministries of state, the Fukushima Prefecture Administration, Tepco (Tokyo Electric Power Company) and the most of the Japanese doctors being under their pressure twist, conceal and manipulate all the unfavourable facts for their pro-nuclear policy. Even the judiciary in Japan is still fully under the influence of political power.

And the vast majority of citizens blindly believes in what is being told by them.

For example, in March 2017, an activist of a citizens' initiative (a relief organization for the radioactively ill or -very likely- children) unveiled that the administration of Fukushima prefecture and its extended arm, namely the Fukushima University Hospital as well as the physicians working under the influence of the Japanese government's pro-nuclear policy didn't any more take care of the children(aged 0 to 18 years old at the Fukushima disaster) who had been suspected of thyroid cancer but not finally confirmed at the second investigation. It came out that those children are 2152. Now they simply say afterwards that they have no information about the further results of their investigation. That means, after the second investigation, only the children who had been diagnosed with cancer and then operated are statiscally shown.

So we don't know how many children of them may also be involved in the cancer.

In addition, unfortunately, we do not have any accurate public information on how many children in the surrounding areas of Fukushima Prefecture are radioactively ill. Concerning individual cases of children of thyroid cancer, who have fled Fukushima or have been in its surrounding areas you can hardly do any research. Even if they are registered in the hospital's card, they will be under the private secret data lists. And Japanese Ministry of Health seems to have absolutely no interest to publish it although they must know the number long ago.

But even so, e.g. a citizens' initiative "3.11 Foundation for thyroid cancer children" found out 12 such children: namely: pref. Miyagi 1, Niigata 1, Gunma1, Nagano 1, Saitama 2, Tokyo 1, Kanagawa 4, Chiba 1 (as of Jan. 31, 2017).

However, this additional figure is, in fact, a fraction of the data being not collected statistically. So, presumably, the real number of the thyroid canser children must be still significantly higher. Consequently, the number of the children in the undermentioned published list is only a part of the reality.

The following list shows the published number of children suffering from thyroid cancer in Fukushima, who were from 0 to 18 years old on 11 March 2011. And the number has been rising since 2011 as follows:

It was therefore a sudden and drastic outbreak of the Thyroid cancer of the children after 11th March 2011 in Fukushima.

Before the Fukushima disaster, the number of thyroid cancer children in Fukushima

was known to be 0 and also in all the other regions of Japan, yearly between 0 and 3or4.

According to a research result of the Okayama Prefecture University (https://news.yahoo.co.jp/byline/kinoryuichi/20151010-00050338/ on Oct. 10, 2015) it is mentioned that the number of thyroid cancers of children in Fukushima is after 2011 is 20 to 50 times higher than other prefectures in Japan.

It is also acknowledged by international leading medical scientists that the thyroid cancer ratio of the children is in normal environments between 1 or 2 to 1 million.

Despite all these facts, the government-controlled Japan's Medical Board does not acknowledge any relation between thyroid cancer children and the Fukushima disaster.

And there are still about 300,000 children (0 to 18 years old) living in the prefecture Fukushima and they are exposed to radioactive radiation everyday. Nevertheless, almost all parents cannot flee with their children Fukushima because of financial reasons, they are also not able to take a cure outside Fukushima together with their children or even to send them alone for cure.

Neither the state, nor local government, nor Tepco(Tokyo Electrical Power Company) give any financial support to them. They say, they don't see any necessities for them to flee Fukushima as well as to take a cure.

The number of the children, who are invited by citizen's initiatives to the cure camps outside of Fukushima every year, even for a few days, with or without parents, is estimated around at 0.2%. And even a part of them won't have any more chance to get it because the citizen's donations are shrinking every year.

Almost without exception, the state and Fukushima prefectural government have all the doctors under their control and let them claim that there is no health danger by the radiation spread for citizens outside of the few remaining immediate evacuation zones and therefore, it is not necessary to take a cure for them although such an assertion cannot be scientifically justified.

The doctors who speak out against the government's pro-nuclear policy are boycotted and threatened by all medical organisations to be discharged from public medical institutions and hospitals, which are under the control of the government and the relevant ministries. Therefore, especially in Fukushima, but also throughout Japan, almost all doctors work exclusively on instructions from the government and their competent authorities.

The Fukushima disaster has clearly shown that in Japan there is no independent neutrality in the field of justice and science.

This shows the tragic reality that all people, especially all children in Fukushima and

in its surroundings are vulnerably exposed to the radiant danger of radioactivity.

2. Purpose of donations:

The donations are intended to help children and parents in/from Fukushima and its surroundings being exposed to the radioactive danger.

3. Recipients of donations:

Recipients of donations must be either children or their parents in/from Fukushima and its surroundings or volunteers on behalf of them.

4. Additional costs:

The costs caused by the voluntary work for the above purpose of donations are covered by the donations.

6. Details of the donation outgos:

6.1 15th June 2018 Donation (Yen:500,000-) to the Citizens' Initiative

"Hoyoo-Net-Yokohama" (=Cure-Net-Yokohama) for the purpose to invite children from Fukushima to the cure camp in the Izu peninsula in summer 2018.



6.2 The cure camp outside the radioactively endangered regions still offers one of the most important recreation opportunities in the psychological and physical sense to the children and their parents in Fukushima. Nevertheless donations to voluntary cure camp organisers decrease every year. So also this citizen's initiative has the same problem. And I decided to support them with the donations from Europe also in summer 2018 because I know their cure camp quite well and that they organize it with many voluntary helpers in an exemplary manner and also that the location of the cure camp and the accommodation fulfill all the conditions in ideal wise.

The location of the cure camp:

The house for their stay is a very large, old house in the traditional Japanese style, located in the greenery and close to the Pacific beach. It belongs to the city Kawazu-cho of the SHIZUOKA Prefecture.

The citizens' initiative Hoyoo (Hoyoo means cure)-Net-Yokohama collects donations since 2012 and has been inviting children with or without their parents from Fukushima to the cure camp in Peninsula IZU / Shizuoka Prefecture for approx. 7 to 10 days during the summer time (end of July to early August) every year. Until 2014, the organizer had paid all costs, i.e. transport, overnight stay, catering etc. for them while some families voluntarily contributed a little. However it became no longer possible for the organizer to bear all those costs because of nonprospect of getting enough donations in the future, but on the other hand, the cure camp for the children is very important as before, therefore the members of the citizen's initiative asked the parents of the children to contribute approx. 20% of the total cost/per person). This means that the cost contribution for adult is Yen:16,000.- per person / children 12 years and older Yen 8,000.- per person /

children up to 11 years Yen4,000.- per person.

Then, this new regulation was not only promptly accepted by them, but also brought a positive effect, namely that the parents from Fukushima got a feeling how important it is, to continue the cure camp together also in future and to protect their own health. However, this rule does not apply to those families for which it is difficult to pay contributions.

All works of planning, organizing and implementing are carried out by the citizens' initiative and about 20 additional volunteers.

6.3 Cure camp in Izu:

Japanese government and Fukushima prefecture administration are reducing financial assistance to the victims of Fukushima and the public is silent, as if the radioactive problem of "Fukushima" doesn't exist anymore. On the contrary, the number of parents in Fukushima acknowledging the importance of taking a cure for them but especially for their children is increasing.

It is, of course, a tiny part of the children whom each individual citizens' initiative can invite to a cure camp. For example, this citizens' initiative can also invite at most only 7 to 8families each summer because of costs and availability of voluntary members.

What I also find very positive about this citizens' initiative is that, with regard to the ever-decreasing amount of donations, they try to find a new method of solving problems.

That means: the families of Fukushima are gradually taking the initiative from year to year to organise the cure camp in Izu, while the citizens' initiative "Hoyoo-Net-Yokohama" (=Kur-Net-Yokohama) impart more and more its acquired know-how about organizing the cure camp to them. Of course, the citizens' initiative "Hoyoo-Net-Yokohama" ist ready, to organize the cure camp as before, but more in cooperatin with the parents from Fukushima and to support their own activities on this issue.

- = 1 parentcouple with 2 children (the mother and the children fled to Tokyo after the Fukushima disaster and now resident there, while the father remains in Fukushima because of his job and sends them household money to Tokyo)
- = 1 mother with 2 children (the mother and the children fled to Tokyo after the Fukushima disaster and now resident there. The escape has also led her to get divorced.

So in this year I have supported the above 2 refugee families with donations from Europa for their summer cure camps 2019 etc.

The children in Fukushima are still exposed to radioactive danger everyday and living at great health risk for cancer etc. But also most of those children and their parents who fled Fukushima are suffering from great financial and psychological hardships.
